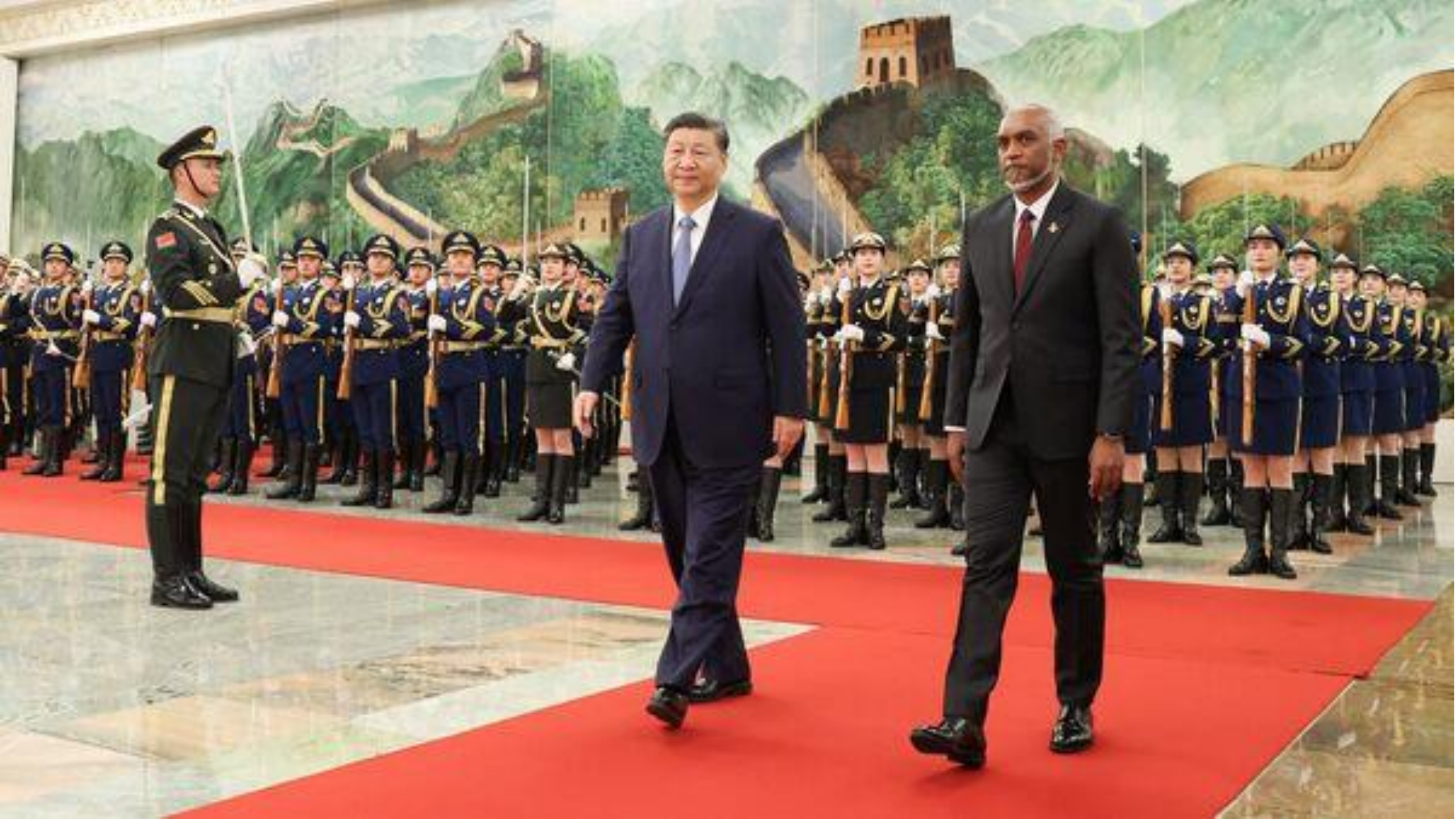

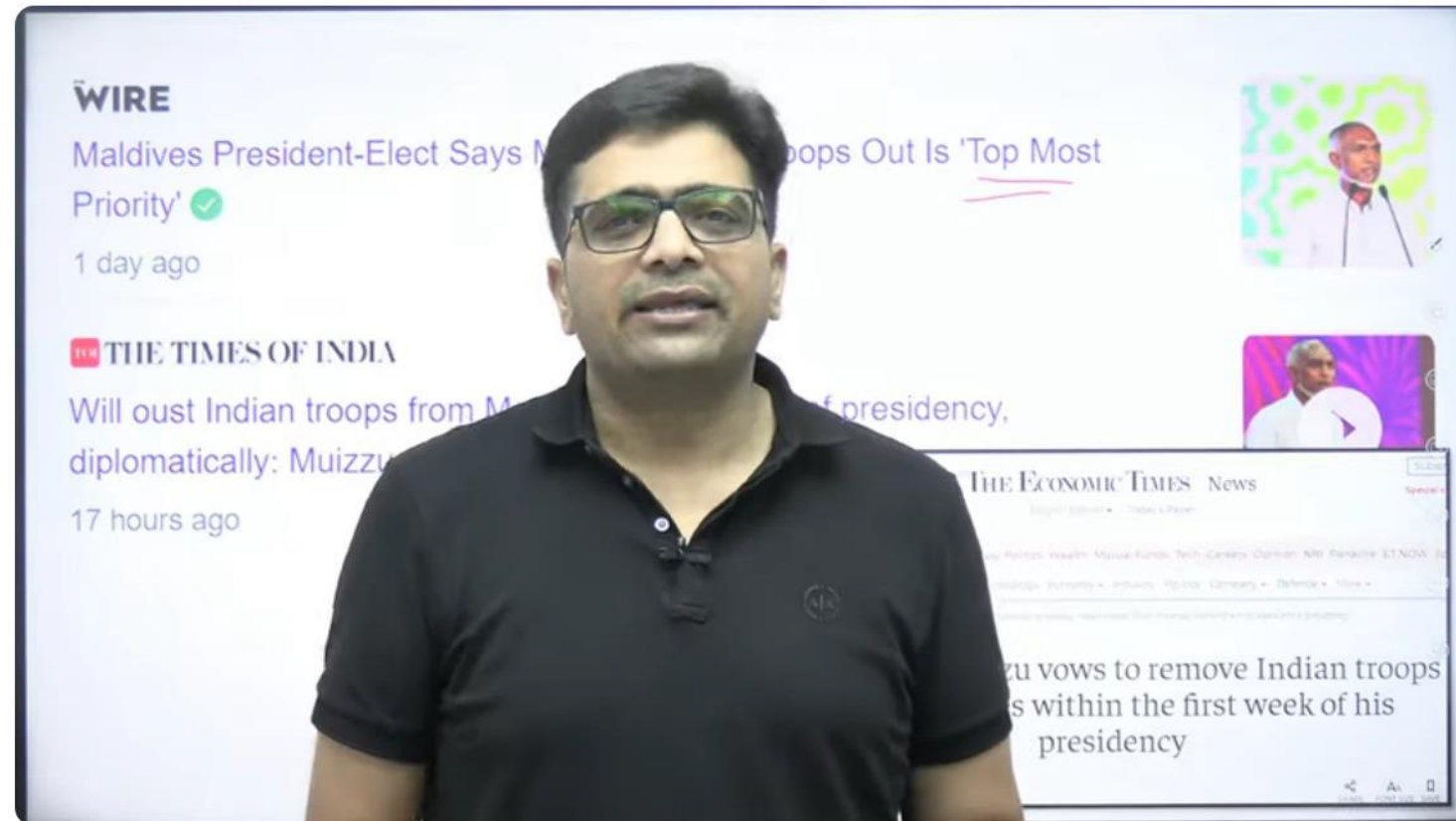

President Mohamed Muizzu, known for his pro-China stance, has thanked India for enabling the resumption of medical evacuation services with civilian aviation personnel from India.

The Maldives National Defence Force (MNDF) told local media that the provision of medical evacuation through the Dornier flight and helicopters has resumed, this time with the civilian crew sent from India, news portal Edition.mv reported.

The two medical emergencies were carried out on Friday night, according to a post on X by the MNDF.

The Dornier aircraft and the helicopters were earlier operated by Indian military personnel and were stopped soon after President Muizzu took oath last November.

President Muizzu rode to power after banking on the 'India Out' sentiment and had pushed for the repatriation of Indian military personnel from his country making a demand to this effect within hours of his swearing-in. According to an agreement between India and Maldives in February this year, all Indian military personnel were to return in batches by May 10 and India kept its word. The military personnel were replaced by civilians as India did not take back the Dornier aircraft and the helicopters it had gifted to the Maldives some years ago.

News portal Adhadhu.com said Indians are stationed in Hanimaadhoo to operate the Dornier aircraft and in Laamu Kadhdhoo and Seenu Gan to operate the helicopters. A total of 76 Indians are based on the islands.

It further said that President Muizzu announced the restart of medical evacuations with the aircraft at the official function held at the youth centre last night to mark the 59th Independence Day.

"A patient was transported to Male' on the India platform for the first time since military personnel were replaced by civilians. I thank the Indian government for this," Muizzu was quoted as saying by Sun.mv news portal.

The resumption of the Dornier aircraft operations came after the government faced criticism for not using the Dornier or the helicopters for medical emergencies, the news portal pointed out.

It also mentioned that the Indian military helicopters in Kadhdhoo and Addu were regularly flown before medical evacuations resumed with the Dornier aircraft. The government has not commented on it.

The civilian personnel were sent by Hindustan Aeronautics Limited – an Indian public sector aerospace and defence company in Bangalore, which manufactured the helicopter donated by the Indian government.

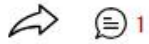

Maldives President Dr Mohamed Muizzu has expressed hope to sign a Free Trade Agreement (FTA) with India, according to Male-based Adhadhu. Male has signed a trade deal with Beijing, which will begin in September. The Maldivian President has expressed hope of signing such an agreement with India as well, the report said.

Speaking at the official function held to mark the 59th anniversary of independence, President Muizzu said that in addition to China, efforts were underway to enter into FTAs with India, Turkiye, and Britain.

Muizzu said the result of implementing the FTA with China would be the elimination of tariffs for a total of 7,897 items in nine sectors, including 298 fisheries products. He said when the FTA comes into force, an import duty will not be charged for exporting these products from the Maldives to China.

When an FTA is signed with Turkiye, duty concessions will be granted for 53 exports from the Maldives with zero tariffs for some items, the President said.

"The government is also working on currency swap agreements with China and India to help local businesses," Muizzu said as per Adhadhu. This would pave the way for alleviating the dollar shortage and assuring economic sovereignty, he said.

Muizzu also spoke of **'Loan Restructuring and Debt Management'**, especially because of its financial bilateral relations with India and China. He acknowledged the **"significant contributions of China and India in assisting with the Maldives' debt repayment efforts"**.

India has deferred a \$50 million loan and provided food quotas for two more years. China has given the green light to defer loans from the Exim Bank for various development projects for the next five years, with no interest payments during this period.

Bilateral Economic and Trade Relations

India and Maldives signed a trade agreement in 1981, which provides for export of essential commodities. Growing from modest beginnings, India-Maldives bilateral trade crossed the USD 300 million mark for the first time in 2021 which further crossed USD 500 million mark in 2022.

शीर्ष अमेरिकी राजनयिक डोनाल्ड लू इस सप्ताह यूएस हाउस फॉरेन अफेयर्स कमेटी के सामने पेश हुए। इस दौरान उन्होंने मालदीव में चीन के बढ़ते कदम को लेकर चिंता जताई और कहा कि अगर हमने कुछ नहीं किया तो मालदीव चीन की कॉलोनी बन जाएगा। इसके साथ ही कहा कि श्रीलंका में चीन का प्रभाव है, लेकिन अब उसे रोक दिया गया है। लू ने चीनी भागीदारी के प्रति संतुलित दृष्टिकोण बनाए रखने में श्रीलंका के प्रयासों की सराहना करते हुए कहा कि श्रीलंका में कोई भी चीनी मिलिट्री बेस नहीं है, क्योंकि हमने और हमारे पार्टनर्स ने श्रीलंका की मदद की। यह टिप्पणी श्रीलंका की ओर से अंतरराष्ट्रीय भागीदारी और निवेश में विविधता लाने से जुड़ी है।

इसके अलावा लू ने भारत के पड़ोसी मालदीव को लेकर चेतावनी दी। दरअसल मालदीव की सत्ता में मोहम्मद मुइज्जु के आने के बाद से वह चीन के करीब हुए हैं। उन्होंने भारत की जगह चीन यात्रा की थी। इसके अलावा भारतीय सैनिकों को भी देश से निकाल दिया था। चीन ने उन्हें बुनियादी ढांचा परियोजना में मदद का आश्वासन दिया है। इसे लेकर लू की टिप्पणी सावधान करने वाली है। उन्होंने कहा कि अगर हमने चीन को सबकुछ करने दिया तो मालदीव के चीनी उपनिवेश बनने का खतरा है।

Maldives Tourism Minister Ibrahim Faisal is slated to visit India today to kick off a series of tourism roadshows under the "Welcome India" initiative. The campaign aims to reinforce the Maldives' status as a prime holiday destination for Indian travellers through a series of events in three major cities.

The roadshow schedule is the following:

- 1. New Delhi: July 30, 2024**
- 2. Mumbai: August 1, 2024**
- 3. Bangalore: August 3, 2024**

This strategic campaign seeks to strengthen tourism ties between the Maldives and India, showcasing the archipelago nation's attractions to potential Indian visitors. Earlier in May this year, the island nation's tourism minister urged Indians to contribute to the country's economy, which is dependent on tourism.

Indian tourists to the Maldives dipped by 42% in the first four months of this year in comparison to the same period in 2023. However, earlier last year, the scenario was quite different. Indian tourists were the highest foreign visitors to the Maldives in 2023, and China was in third place.

As per the data, the Maldives received 73,785 tourists from India between January and April 2023. On the other hand, the island nation recorded 42,638 tourist arrivals in the same period this year — a decline of 31,147 tourists in absolute terms.

Statistics show 15,006 Indians visited the island nation in January 2024. In February, 11,252 Indian tourists visited the island nation, as compared to 24,632 tourists the same month last year.

2- अवगत कराना है कि यह परीक्षा पूर्व में निरस्त कर दी गयी थी। मा0 मुख्यमंत्री, उत्तर प्रदेश द्वारा निर्देशित किया गया था कि यह परीक्षा 06 माह के अन्दर शुचिता एवं पारदर्शिता के उच्चतम मानकों को दृष्टिगत रखते हुये पुनः आयोजित करायी जाए। उत्तर प्रदेश सरकार द्वारा इस परीक्षा को एक निश्चित समय सीमा के अन्तर्गत शुचितापूर्ण एवं पारदर्शी तरीके से उच्चतम मानकों के अनुसार आयोजित करने की प्रतिबद्धता के क्रम में यह कार्यक्रम घोषित किया गया है।

5- उत्तर प्रदेश पुलिस भर्ती एवं प्रोन्नति बोर्ड द्वारा "आरक्षी नागरिक पुलिस के 60244 पदों पर सीधी भर्ती-2023" की लिखित परीक्षा उपरोक्त उल्लिखित तिथियों में आयोजित की जायेगी। जन्माष्टमी त्योहार के कारण परीक्षा में अंतराल दिया गया है। उक्त तिथियों को प्रतिदिन 02 पालियों में यह परीक्षा सम्पन्न होगी तथा प्रति पाली में लगभग 5 लाख अभ्यर्थी इस परीक्षा में सम्मिलित होंगे।

“[The] Ministry of Electronics and Information Technology (MeitY) has shared that WhatsApp or Meta has not informed the government about any such plans,” Vaishnaw said in a written reply to a question by Congress member Vivek Tankha, as per PTI report on Friday (July 26).

Tankha had asked whether WhatsApp was planning to shut its services in India due to the government's directives to share user details in accordance with the government directions under Section 69A of the Information Technology Act, 2000.

Responding to Tankha's question on curbs on social media platforms, the I&B minister said the central government issued directions in the interest of the sovereignty or integrity of India, defence of India, security of the state, friendly relations with foreign states or public order or for preventing incitement to the commission of any cognisable offence relating to above in respect of the information on a computer resource.

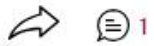

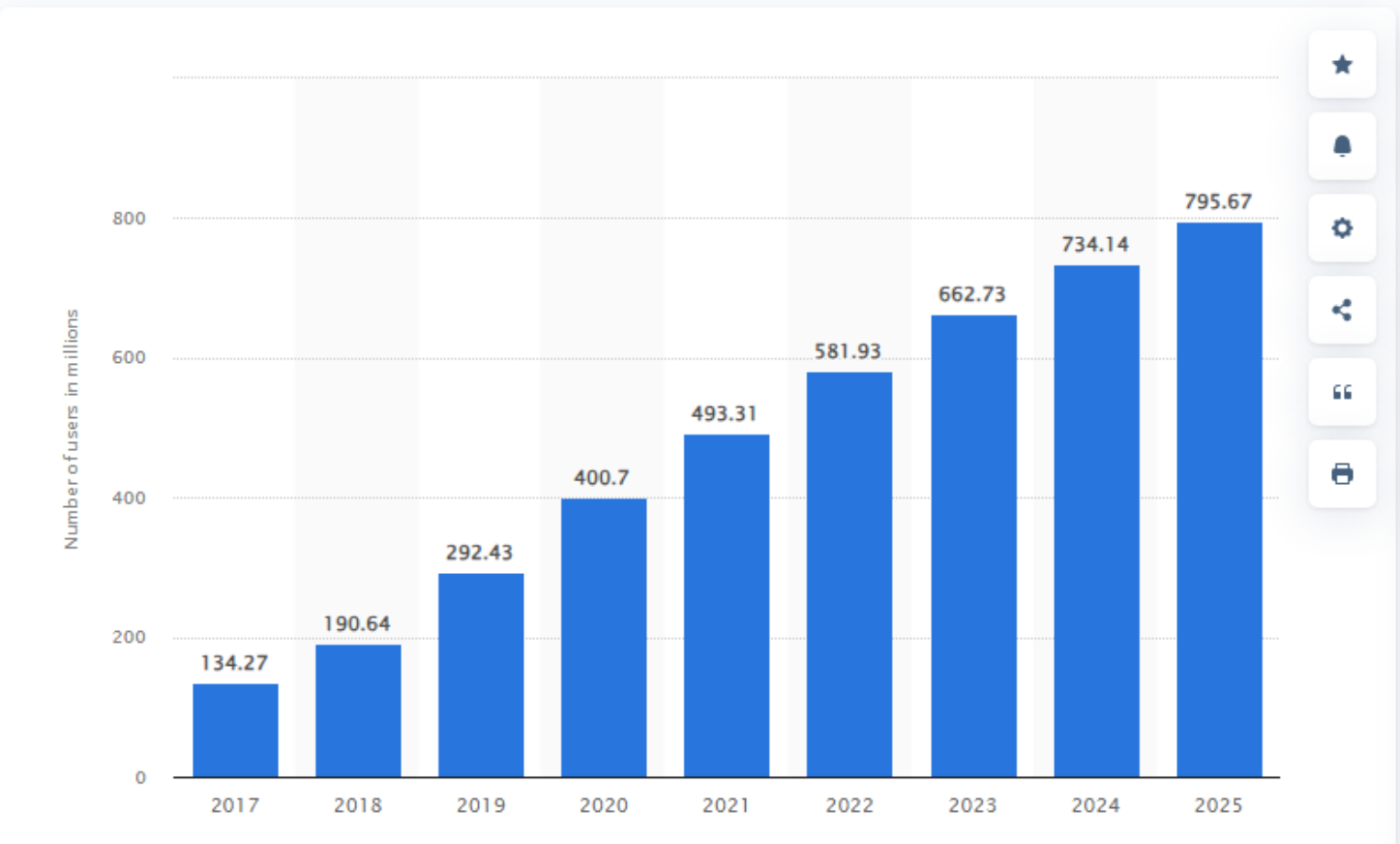

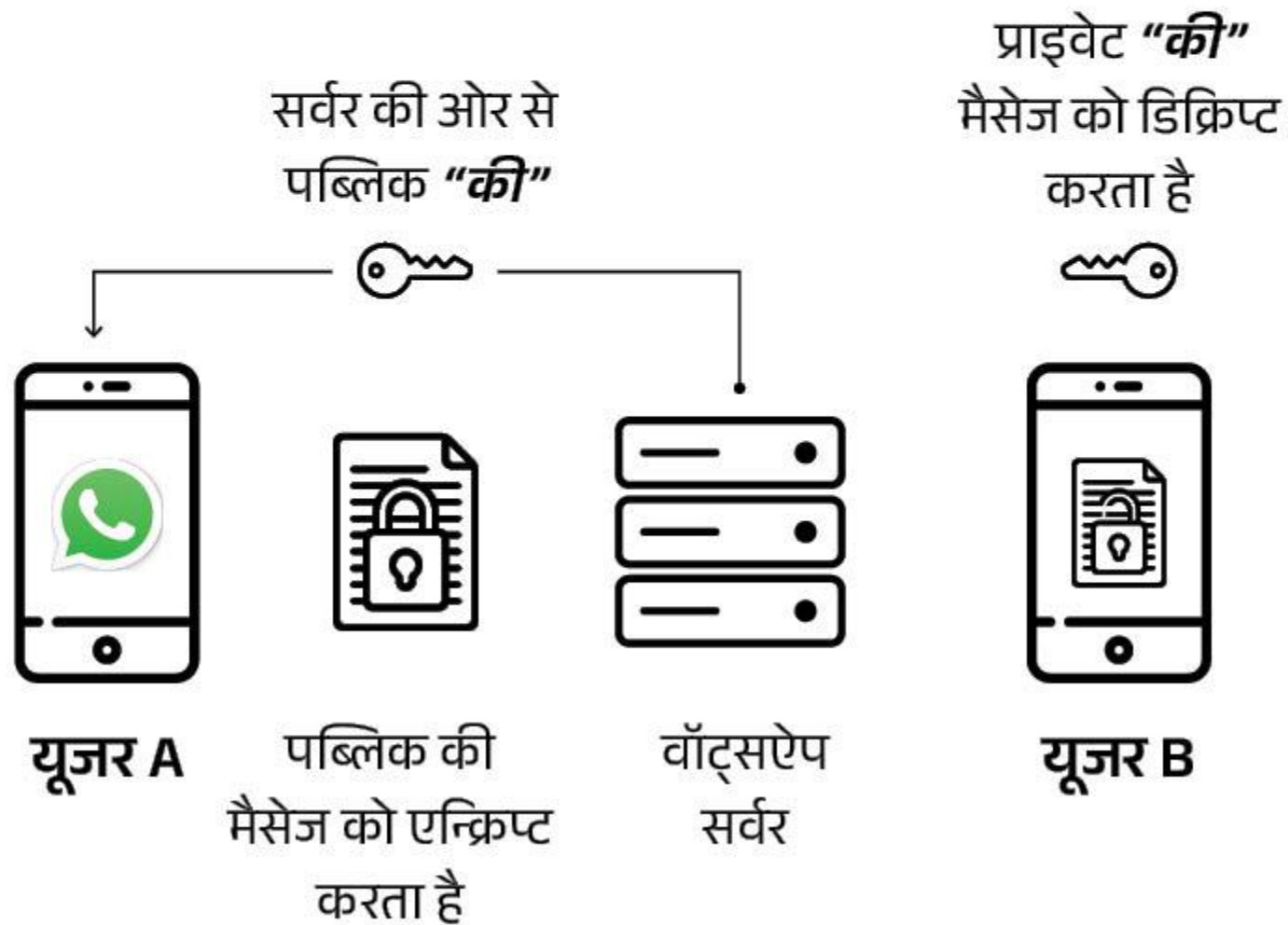

Government notifies Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules 2021

Amidst growing concerns around lack of transparency, accountability and rights of users related to digital media and after elaborate consultation with the public and stakeholders, the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules 2021 has been framed in exercise of powers under section 87 (2) of the Information Technology Act, 2000 and in supersession of the earlier Information Technology (Intermediary Guidelines) Rules 2011.

While finalizing these Rules, both the Ministries of Electronics and Information Technology and Ministry of Information and Broadcasting undertook elaborate consultations among themselves in order to have a harmonious, soft-touch oversight mechanism in relation to social media platform as well as digital media and OTT platforms etc.

Part- II of these Rules shall be administered by Ministry of Electronics and IT, while Part-III relating to Code of Ethics and procedure and safeguards in relation to digital media shall be administered by the Ministry of Information and Broadcasting.

Background:

The Digital India programme has now become a movement which is empowering common Indians with the power of technology. The extensive spread of mobile phones, Internet etc. has also enabled many social media platforms to expand their footprints in India. Common people are also using these platforms in a very significant way. Some portals, which publish analysis about social media platforms and which have not been disputed, have reported the following numbers as user base of major social media platforms in India:

- WhatsApp users: 53 Crore
- YouTube users: 44.8 Crore
- Facebook users: 41 Crore
- Instagram users: 21 Crore
- Twitter users: 1.75 Crore

Salient Features

Guidelines Related to Social Media to Be Administered by Ministry of Electronics and IT:

- **Due Diligence To Be Followed By Intermediaries:** The Rules prescribe due diligence that must be followed by intermediaries, including social media intermediaries. In case, due diligence is not followed by the intermediary, safe harbour provisions will not apply to them.
- **Grievance Redressal Mechanism:** The Rules seek to empower the users by mandating the intermediaries, including social media intermediaries, to establish a grievance redressal mechanism for receiving resolving complaints from the users or victims. Intermediaries shall appoint a Grievance Officer to deal with such complaints and share the name and contact details of such officer. Grievance Officer shall acknowledge the complaint within twenty four hours and resolve it within fifteen days from its receipt.
- **Ensuring Online Safety and Dignity of Users, Specially Women Users:** Intermediaries shall remove or disable access within 24 hours of receipt of complaints of contents that exposes the private areas of individuals, show such individuals in full or partial nudity or in sexual act or is in the nature of impersonation including morphed images etc. Such a complaint can be filed either by the individual or by any other person on his/her behalf.
- **Two Categories of Social Media Intermediaries:** To encourage innovations and enable growth of new social media intermediaries without subjecting smaller platforms to significant compliance requirement, the Rules make a distinction between social media intermediaries and significant social media intermediaries. This distinction is based on the number of users on the social media platform. Government is empowered to notify the threshold of user base that will distinguish between social media intermediaries and significant social media intermediaries. The Rules require the significant social media intermediaries to follow certain additional due diligence.
- **Additional Due Diligence to Be Followed by Significant Social Media Intermediary:**
 - Appoint a **Chief Compliance Officer** who shall be responsible for ensuring compliance with the Act and Rules. Such a person should be a resident in India.
 - Appoint a **Nodal Contact Person** for 24x7 coordination with law enforcement agencies. Such a person shall be a resident in India.
 - Appoint a **Resident Grievance Officer** who shall perform the functions mentioned under Grievance Redressal Mechanism. Such a person shall be a resident in India.
 - Publish a **monthly compliance report** mentioning the details of complaints received and action taken on the complaints as well as details of contents removed proactively by the significant social media intermediary.
 - Significant social media intermediaries providing services primarily in the nature of messaging shall enable **identification of the first originator of the information** that is required only for the purposes of prevention, detection, investigation, prosecution or punishment of an offence related to sovereignty and integrity of India, the security of the State, friendly relations with foreign States, or public order or of incitement to an offence relating to the above or in relation with rape, sexually explicit material or child sexual abuse material punishable with

- Publish a **monthly compliance report** mentioning the details of complaints received and action taken on the complaints as well as details of contents removed proactively by the significant social media intermediary.
- Significant social media intermediaries providing services primarily in the nature of messaging shall enable **identification of the first originator of the information** that is required only for the purposes of prevention, detection, investigation, prosecution or punishment of an offence related to sovereignty and integrity of India, the security of the State, friendly relations with foreign States, or public order or of incitement to an offence relating to the above or in relation with rape, sexually explicit material or child sexual abuse material punishable with imprisonment for a term of not less than five years. **Intermediary shall not be required to disclose the contents of any message** or any other information to the first originator.
- Significant social media intermediary shall have a physical contact address in India published on its website or mobile app or both.
- **Voluntary User Verification Mechanism:** Users who wish to verify their accounts voluntarily shall be provided an appropriate mechanism to verify their accounts and provided with demonstrable and visible mark of verification.
- **Giving Users An Opportunity to Be Heard:** In cases where significant social media intermediaries removes or disables access to any information on their own accord, then a prior intimation for the same shall be communicated to the user who has shared that information with a notice explaining the grounds and reasons for such action. Users must be provided an adequate and reasonable opportunity to dispute the action taken by the intermediary.
- **Removal of Unlawful Information:** An intermediary upon receiving actual knowledge in the form of an order by a court or being notified by the Appropriate Govt. or its agencies through authorized officer should not host or publish any information which is prohibited under any law in relation to the interest of the sovereignty and integrity of India, public order, friendly relations with foreign countries etc.
- The Rules will come in effect from the date of their publication in the gazette, except for the **additional due diligence for significant social media intermediaries**, which shall **come in effect 3 months after** publication of these Rules.

Digital Media Ethics Code Relating to Digital Media and OTT Platforms to Be Administered by Ministry of Information and Broadcasting:

There have been widespread concerns about issues relating to digital contents both on digital media and OTT platforms. Civil Society, film makers, political leaders including Chief Minister, trade organizations and associations have all voiced their concerns and highlighted the imperative need for an appropriate institutional mechanism. The Government also received many complaints from civil society and parents requesting interventions. There were many court proceedings in the Supreme Court and High Courts, where courts also urged the Government to take suitable measures.

Since the matter relates to digital platforms, therefore, a conscious decision was taken that issues relating to digital media and OTT and other creative programmes on Internet shall be administered by the Ministry of Information and Broadcasting but the overall architecture shall be under the Information Technology Act, which governs digital platforms.

Are WhatsApp, Facebook complying with the new rules?

While Facebook has said that it aims to comply with the provisions of the IT rules, WhatsApp has filed a lawsuit against the government seeking a ban on regulations coming into force on Wednesday. As per a Reuters report, WhatsApp had asked the Delhi High Court to declare one of the rules as a violation of privacy rights because it forces the social media companies to trace the "first originator of information" when the government demands it. This law would compel WhatsApp to go against its own policy as the app is end-to-end encrypted. Tracing the originator of the message would mean circumventing the end-to-end encryption.

Talking about why WhatsApp is challenging the Indian government's IT rules, a WhatsApp spokesperson told, "Requiring messaging apps to 'trace' chats is the equivalent of asking us to keep a fingerprint of every single message sent on WhatsApp, which would break end-to-end encryption and fundamentally undermines people's right to privacy. We have consistently joined civil society and experts around the world in opposing requirements that would violate the privacy of our users. In the meantime, we will also continue to engage with the Government of India on practical solutions aimed at keeping people safe, including responding to valid legal requests for the information available to us."

Centre opposes WhatsApp's plea in Delhi HC challenging new IT rules

The [Centre](#) has defended in the Delhi High Court the legal validity of its new IT rule requiring messaging apps, such as [WhatsApp](#), to "trace" the first originator of the information, saying that the law empowers it to expect such entities to create safe cyberspace and counter illegal content either themselves or by assisting the law enforcement agencies. The Centre said

that Section 87 of the Information Technology Act gave it the power to formulate Rule 4(2) of the Intermediary Rules -- which mandates a significant social media intermediary to enable the identification of the first originator of information in "legitimate state interest" of curbing the menace of fake news and offences concerning national security and public order as well as women and children.

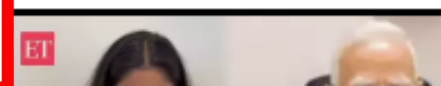

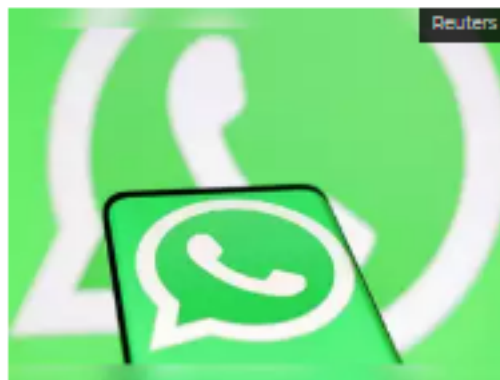
WhatsApp tells Delhi High Court it will shut down if forced to break encryption

WhatsApp said that the contents of the exchanges shared on its platform cannot be traced by any party other than the sender and the receiver as it's end-to-end encrypted in order to protect the privacy of the parties. People use the messaging platform because of the privacy assured by it and also because messages are end-to-end encrypted, its lawyer said.

[WhatsApp LLC](#) on Thursday told the [Delhi High Court](#) that the popular messaging platform will end if it is made to break [encryption](#) of [messages](#).

वॉट्सऐप की ओर से ये बात दिल्ली हाईकोर्ट में चल रहे एक मामले की सुनवाई के वक्त कही गई है. कोर्ट में WhatsApp और उसकी पैरेंट कंपनी Facebook Inc (अब Meta) की याचिकाओं पर सुनवाई हो रही है, जिसमें 2021 Information Technology (IT) के नियमों को चुनौती दी गई है.

दिल्ली हाईकोर्ट बोला- बीच का रास्ता निकालें

वॉट्सऐप की ओर से एडवोकेट तेजस करिया और सरकार की ओर से कीर्तिमान सिंह दलील रख रहे थे। दोनों पक्षों के बीच संक्षिप्त बहस के बाद हाईकोर्ट ने बीच का रास्ता निकालने को कहा। मामले की अगली सुनवाई 14 अगस्त को होगी।

कोर्ट में वॉट्सऐप के वकील की 3 बड़ी बातें

- IT नियम 2021 एन्क्रिप्शन के साथ यूजर्स की गोपनीयता को कमजोर करता है। यह भारतीय संविधान के अनुच्छेद 14, 19 और 21 के तहत मौलिक अधिकारों का भी उल्लंघन करता है।
- दुनिया में कहीं और ऐसा कोई नियम नहीं है, ब्राजील में भी नहीं। यह नियम उपयोगकर्ताओं की गोपनीयता के खिलाफ है और नियम बिना किसी परामर्श के पेश किया गया था।
- हमें एक पूरी श्रृंखला रखनी होगी और हमें नहीं पता कि किन मैसेज को सरकार मांग सकती है। इसका मतलब है कि करोड़ों मैसेज वर्षों तक स्टोर करना होगा।

मामले में सरकार ने 4 बड़ी बातें कही

- एडवोकेट कीर्तिमान सिंह ने कहा कि इस गाइडलाइन के पीछे का विचार मैसेज के सोर्स का पता लगाना था। वैसे भी, समय के अनुसार मैसेज को ट्रैस करने का कोई मैकेनिज्म होना ही चाहिए।

It is keeping aside a war chest of \$3 billion for these acquisitions, these people said. The group is aggressively pursuing an inorganic strategy to boost capacity and emerge as the largest cement manufacturer within the next three to four years, overtaking the Aditya Birla Group's UltraTech.



Mumbai: The Adani Group is evaluating multiple cement companies for acquisition including Hyderabad-based [Penna Cement](#), Gujarat-headquartered [Saurashtra Cement](#) and the cement business of [Jaiprakash Associates](#) as well as ABG Shipyard-owned [Vadraj Cement](#), according to people familiar with the matter.

As of June 2024, Adani Group's Ambuja Cements has made several cement acquisitions, including:

- **Penna Cement**

Ambuja Cements acquired Penna Cement to gain access to southern and eastern India, as well as Sri Lanka. The acquisition also strengthens Adani's sea transportation logistics with five bulk cement terminals.

- **Sanghi Industries**

Ambuja Cements acquired Sanghi Industries in Gujarat in FY24, which increased its production capacity and coastal footprint.

- **MyHome Industries**

Ambuja Cements agreed to acquire MyHome Industries' grinding unit in Tamil Nadu in April 2024.

- **As of June 2024, the Adani Group's cement business, which includes Ambuja Cement and its subsidiary ACC Ltd, has an annual production capacity of 77.4 million tonnes.**
- **The Adani Group's cement capacity has grown rapidly in recent years, largely through inorganic means. In May 2022, the group acquired Ambuja Cement and ACC for \$10.5 billion, and more recently, it bought out Hyderabad-based Penna Cements for Rs 10,420 crore, which includes a capacity of 10 mtpa and another 4 mtpa under construction. The group also plans to expand its capacity further, with a target of reaching 140 mtpa by the end of 2027.**
- **Priority projects for FY23-24 include brownfield grinding plants in Sankrail, Bhatinda, and Farakka, as well as greenfield projects in Kharagpur, Hoshiarpur, and Mirzapur. The group also plans to acquire Sanghi Industries to add 6.1 mtpa of capacity at Sanghipuram in western India, and Ambuja Cements is constructing a 6 mtpa cement plant in Telangana.**

What is the mission?

As part of the National Mission on Natural Farming (NMNF), the government intends to motivate farmers to adopt chemical-free farming and draw them towards adopting natural farming willingly on the system's merit. The government believes that the success of the NMNF will require a behavioural change in farmers to shift from chemical-based inputs to cow-based, locally-produced inputs. The natural farming scheme under the 'Bharatiya Prakritik Krishi Paddhati' has a total outlay of ₹4,645.69 crore for six years (2019-20 to 2024-25).

There are several states practicing Natural Farming. Prominent among them are Andhra Pradesh, Chhattisgarh, Kerala, Gujarat, Himachal Pradesh, Jharkhand, Odisha, Madhya Pradesh, Rajasthan, Uttar Pradesh and Tamil Nadu.

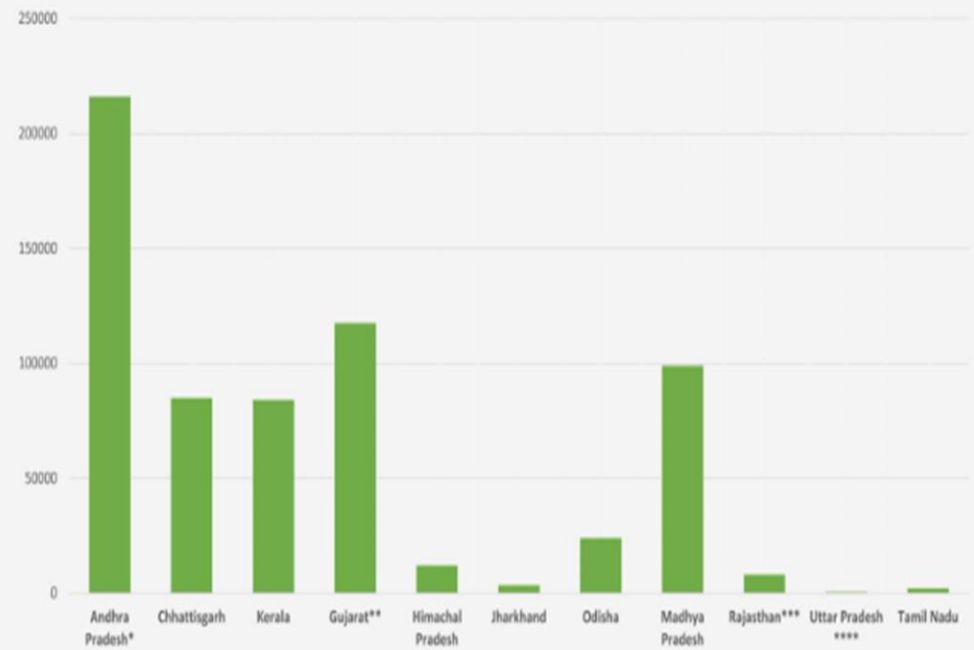

Efforts to promote natural farming:

In the next two years, one crore farmers across the country will be initiated into natural farming supported by certification and branding.

- Its implementation will be through scientific institutions and willing gram panchayats. Besides, 10,000 need-based bio-input resource centres will be established.**

The need for the shift - from targeting the area coverage to number of farmers now - was felt as 30-40% of about 10 lakh farmers re-shifted to chemical farming after 3 years when they received complete financial incentives under the Bharatiya Prakritik Krishi Paddhati (BPKP).

Natural, Organic and Zero-Budget Natural Farming (ZBNF)?

Natural farming and organic farming, both come under agroecological practices (which guides public policies towards sustainable agriculture and food systems) and are terms used interchangeably in India.

In natural farming the focus is on the use of bio inputs prepared from farm and local ecosystems instead of purchasing those from outside.

ZBNF is one of the many methods of natural farming, popularised by agriculturist Subash Palekar.

- According to the approach, a mixture of natural inputs like cow urine and dung, jaggery, lime, neem, etc., are used to improve soil health, nutrients and reduce input costs.
- It also restores environmental health and mitigates and/or reduces greenhouse gas emissions.
- Organic farming is defined more from a perspective of product certification. What binds organic and natural farming is the thrust on the absence of application of chemical fertilisers/ pesticides during cultivation.

ZBNF, aptly named 'zero budget,' entails minimal expenditure on inputs, with the costs of cultivating the main crop offset by income generated from intercrops.

Its key components include:

- Soil Aeration**
- Minimal Watering to save electricity**
- Intercropping**
- Construction of bunds and topsoil mulching**

Furthermore, ZBNF discourages practices such as intensive irrigation and deep ploughing while opposing the use of vermicompost. Instead, it advocates for the revival of local deep soil earthworms through increased organic matter.

Government Initiatives to Promote Natural Farming in India:

1. Paramparagat Krishi Vikas Yojana (PKVY):

It was launched in 2015, as an extended component of Soil Health Management (SHM) under the Centrally Sponsored Scheme (CSS), National Mission on Sustainable Agriculture (NMSA).

The primary objectives of the PKVY are:

- Promotion of commercial organic production through certified organic farming.**
- Production of pesticide residue-free crops to enhance consumer health.**
- Enhancement of farmers' income and the creation of potential markets for traders.**
- Assurance of long-term soil fertility, conservation of resources, and adaptation and mitigation of climate change effects.**

2. BHARTIYA PRAKRITIK KRISHI PADHHATI YOJANA:

The Bharatiya Prakritik Krishi Paddhati (BPKP) Scheme for Natural Farming was launched by the Ministry of Agriculture & Farmers Welfare in the fiscal year 2019-20 and 2024-25.

It is a sub-scheme of the PKVY (Paramparagat Krishi Vikas Yojana) and was launched with a total outlay of ₹4,645 crore for six years (2019-20 to 2024-25).

Key highlights of the BPKP Scheme include:

- Elimination of synthetic chemical inputs.**
- On-farm biomass recycling with a strong emphasis on biomass mulching.**
- Utilization of cow dung-urine formulations.**
- Adoption of plant-based preparations.**
- Regular soil working for aeration purposes.**

3. National Mission on Natural Farming (NMNF):

The Union Agriculture Ministry has been preparing to launch the Mission to motivate farmers to adopt chemical-free farming and draw them towards adopting natural farming willingly on the system's merit.

The success of the NMNF will require a behavioural change in farmers to shift from chemical-based inputs to cow-based, locally-produced inputs.



BENEFITS OF NATURAL FARMING

1. Cost-effective Production: Natural farming minimizes the need for expensive equipment and eliminates the use of chemical fertilizers and pesticides, reducing production costs.

2. Healthier Food: The food produced through natural farming is richer in nutrients and free from harmful chemicals, promoting better health and well-being.

3. Environmental Conservation: Natural farming reduces chemical residues and carbon emissions, contributing to environmental preservation. By integrating crops, trees, and livestock with functional biodiversity, it fosters a sustainable agroecology-based farming system.

4. Efficient Water Use: Unlike modern commercial farming, which often leads to over-extraction of groundwater, natural farming optimizes soil moisture utilization, promoting efficient water use.

5. Soil Health Promotion: Conventional chemical-based farming depletes soil nutrients and disrupts microbial balance. In contrast, natural farming fosters the growth of beneficial organisms like earthworms, enhances soil enzymes, and boosts microbial biomass, leading to soil restoration and improved health.

6. Increase Farmer Income:

Reduce input costs and increase the profitability of farming through sustainable practices.

Provide market linkages and support to farmers practising chemical-free farming.

CHALLENGES OF NATURAL FARMING:

- 1. Yield Decline:** Some regions, such as Sikkim, the first organic state in India, have experienced a decline in yields after transitioning to organic farming. This has led to farmers reverting to conventional methods.
 - Findings of agro-scientists of the ICAR-IIFSR highlights a 59% decline in wheat yields and a 32% decline in basmati rice yield compared to integrated crop management.
- 2. Shortage of Natural Inputs:** The lack of readily available natural inputs poses a barrier to transitioning to chemical-free agriculture, causing delays and hindering profitable farming practices.

3. Resistance from Chemical Industry: The chemical inputs industry, being capital-intensive and well-established, tends to resist efforts towards promoting natural farming, impeding its widespread adoption.

4. Lessons from Sri Lanka:

- A couple of years ago, neighbouring Sri Lanka went through economic and political turmoil after it decided to turn completely organic, and banned the import of chemical fertilisers.
- The government's policy shift had severe consequences with farmers struggling to get natural fertilisers.
- They faced a reduction in yields of key crops including rice, putting the country's food security at risk.
- A sharp price escalation was witnessed in the country, resulting in huge protests and unrest.



Way Forward Ensuring Gradual Adoption of Natural Farming in India:

1. Rigorous scientific tests of natural farming: Especially surrounding the crop yields should be held before its nationwide implementation to allay the fear of potential risk to national food security.

2. Natural farming at a localised level: Because, adopting it at a large scale may not be a successful model.

- First, natural farming can be used to grow supplementary foodstuffs: Instead of growing staples like wheat and rice.

Conclusion:

- **Focusing on natural farming can bring multiple environmental, health, and economic benefits to India.**
- **However, successful implementation requires addressing challenges through adequate policy support, market development, and farmer education.**
- **By fostering a more sustainable agricultural model, India can enhance food security, promote rural development, and contribute to global efforts against climate change.**

Moidams – the Mound-Burial System of the Ahom Dynasty

Set in the foothills of the Patkai Ranges in eastern Assam, the property contains the royal necropolis of the Tai-Ahom. For 600 years, the Tai-Ahom created moidams (burial mounds) accentuating the natural topography of hills, forests and water, thus forming a sacred geography. Banyan trees and the trees used for coffins and bark manuscripts were planted and water bodies created. Ninety moidams – hollow vaults built of brick, stone or earth – of different sizes are found within the site. They contain the remains of kings and other royals together with grave goods such as food, horses and elephants, and sometimes queens and servants. The Tai-Ahom rituals of “Me-Dam-Me-Phi” and “Tarpan” are practiced at the Charaideo necropolis. While moidams are found in other areas within the Brahmaputra Valley, those found at the property are regarded as exceptional.

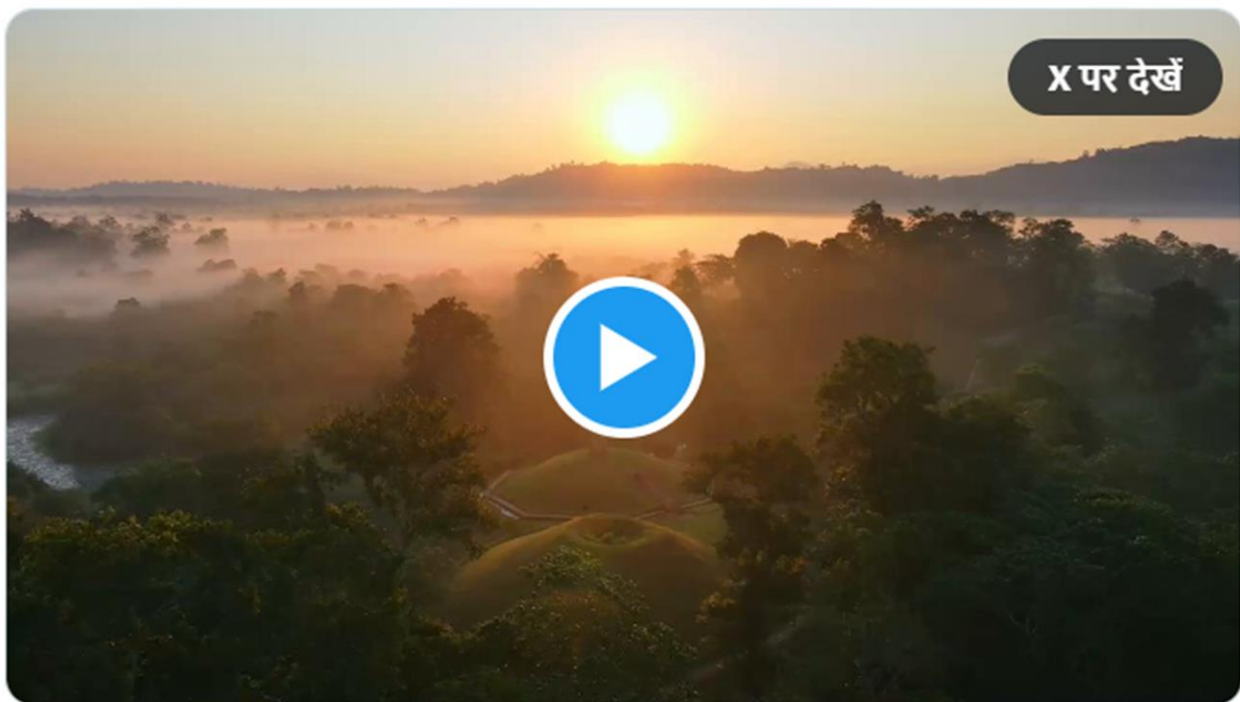

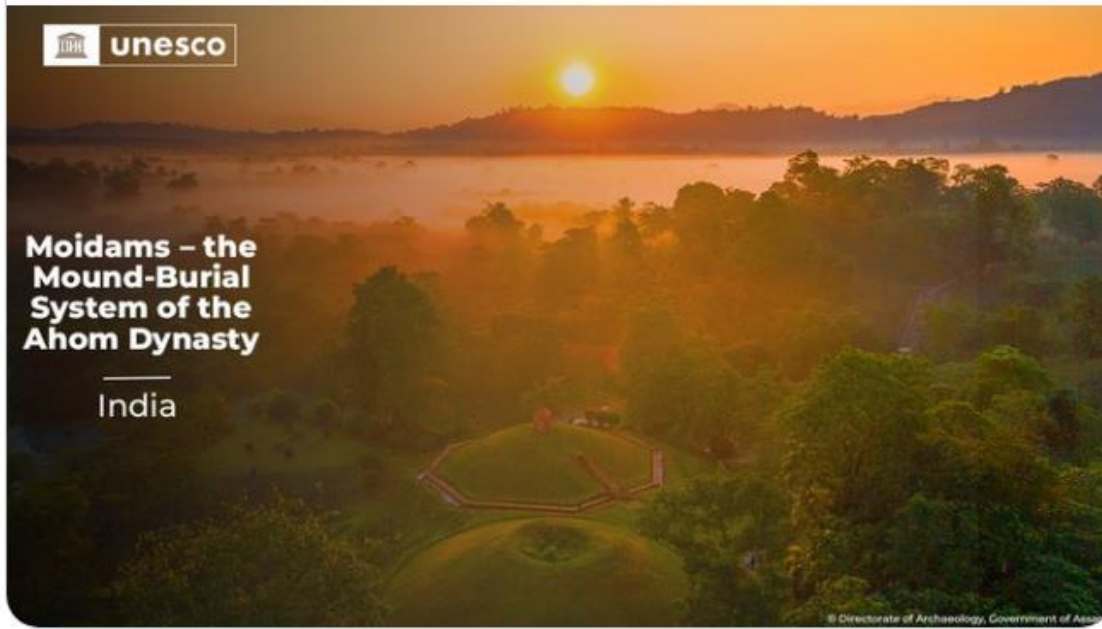

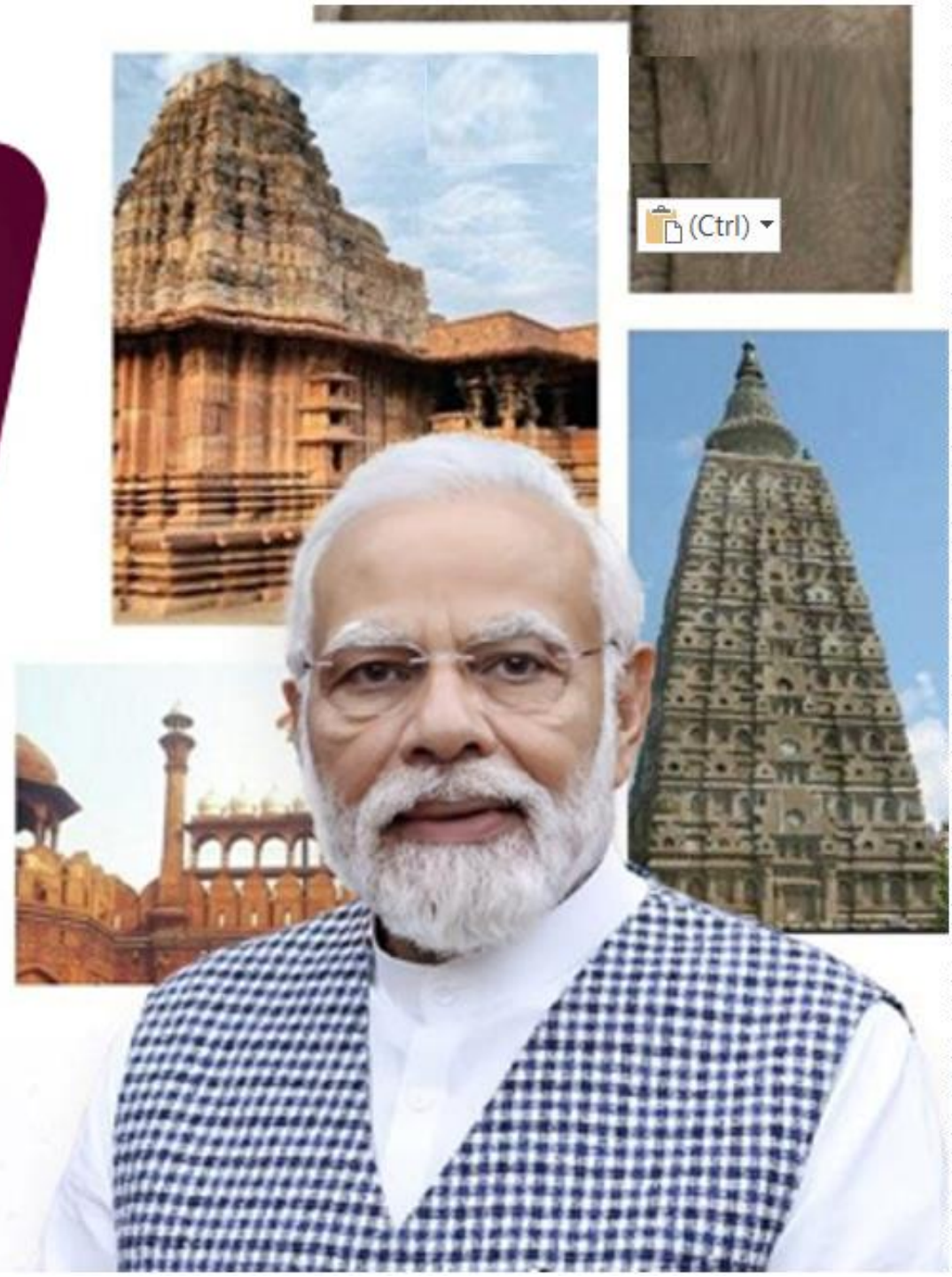
Assam's Moidams to be considered for World Heritage List:

The Moidams in eastern Assam — a 700-year-old mound-burial system of the Ahom dynasty — made it to UNESCO's World Heritage List on Friday, becoming the first cultural site from the Northeast to make it to the list. The decision was taken during the 46th session of the World Heritage Committee (WHC) underway in India.

The nomination dossier for the Moidams was sent more than a decade ago. Reacting to this, Culture Minister Gajendra Singh Shekhawat said that the “day would be etched in golden letters”. Thanking UNESCO, he added: “We thank UNESCO, World Heritage Committee for understanding the outstanding universal value of ‘Moidams’.”

46th Session of World Heritage Committee from July 21 to 31 at Bharat Mandapam:

India became a member of the World Heritage Committee from 2021-25 and is currently hosting its first session since joining the 1972 UNESCO World Heritage Convention. The 46th Session of the World Heritage Committee began on July 21 and will run until July 31 at Bharat Mandapam in New Delhi.

The annual meeting was attended by over 150 State Parties, all of whom are signatories to the UNESCO World Heritage Convention and are responsible for managing matters related to World Heritage, including the inscription of new sites.

केंद्रीय संस्कृति और पर्यटन मंत्री गजेंद्र सिंह शेखावत ने इस घोषणा के बाद कहा कि यह ऐतिहासिक मान्यता चराइदेव में अहोम राजाओं की अद्वितीय 700 साल पुरानी टीले की दफन प्रणाली पर वैश्विक ध्यान आकर्षित करती है, जो असम और भारत की समृद्ध सांस्कृतिक विरासत पर प्रकाश डालती है। इस प्रतिष्ठित मान्यता की ओर मोइदमस की यात्रा का नेतृत्व प्रधानमंत्री श्री नरेन्द्र मोदी ने किया, जिन्होंने इन प्राचीन संरचनाओं को 2023 में भारत की आधिकारिक प्रविष्टि के रूप में नामित किया। उन्होंने कहा कि यह नामांकन मोइदमस के सांस्कृतिक और ऐतिहासिक महत्व को रेखांकित करता है, जिससे वे विश्व विरासत सूची में अंकित होने वाले पहले सांस्कृतिक विरासत स्थल और उत्तर पूर्व से तीसरे समग्र स्थल बन गए हैं।

Assam Chief Minister Himanta Biswa Sharma, reacting to the news, said: **“The Moidams make it to the UNESCO World Heritage list under the category Cultural Property – a great win for Assam... It is the first time a site from the North East has made it to the UNESCO World Heritage List under the Cultural Category and after Kaziranga and Manas National Parks, it is Assam’s third World Heritage Site.”**

What is United Nations Educational, Scientific and Cultural Organization (UNESCO)?

- It is a specialised agency of the United Nations (UN), headquartered at the World Heritage Centre in Paris, France.**
- It was founded in 1945 as the successor to the League of Nation's International Committee on Intellectual Cooperation.**
- It was established with an aim to promote world peace and security through international cooperation in five key program areas - Education; Natural sciences; Social or human sciences; Culture; Communication/information.**

- **UNESCO is a member of the United Nations Sustainable Development Group.**
- Thus, UNESCO's programmes contribute to the achievement of the *SDGs (Sustainable Development Group)* defined in the **2030** Agenda, adopted by the UN General Assembly in **2015**.
- It **aids** in the translation and dissemination of world literature, assists in **the establishment and protection of World Heritage Sites of cultural and natural importance, works to bridge the global digital divide, etc.**



The World Heritage Committee?

The World Heritage Committee, consisting of representatives from 21 States Parties elected by their General Assembly of UNESCO, meets once a year.

The Committee is responsible for implementing the World Heritage Convention, determining the use of the World Heritage Fund, and allocating financial assistance upon requests from States Parties.

It decides whether a property is inscribed on the World Heritage List, examines reports on the conservation of inscribed properties, and requests action from States Parties if properties are not properly managed.

The Committee also decides on the addition or removal of properties from the List of World Heritage in Danger.

What is World Heritage?

World Heritage is the designation for places on Earth that are of outstanding universal value to humanity and as such, have been inscribed on the World Heritage List to be protected for future generations to appreciate and enjoy. Places as diverse and unique as the Pyramids of Egypt, the Great Barrier Reef in Australia, Galápagos Islands in Ecuador, the Taj Mahal in India, the Grand Canyon in the USA, or the Acropolis in Greece are examples of the 1007 natural and cultural places inscribed on the World Heritage List to date.

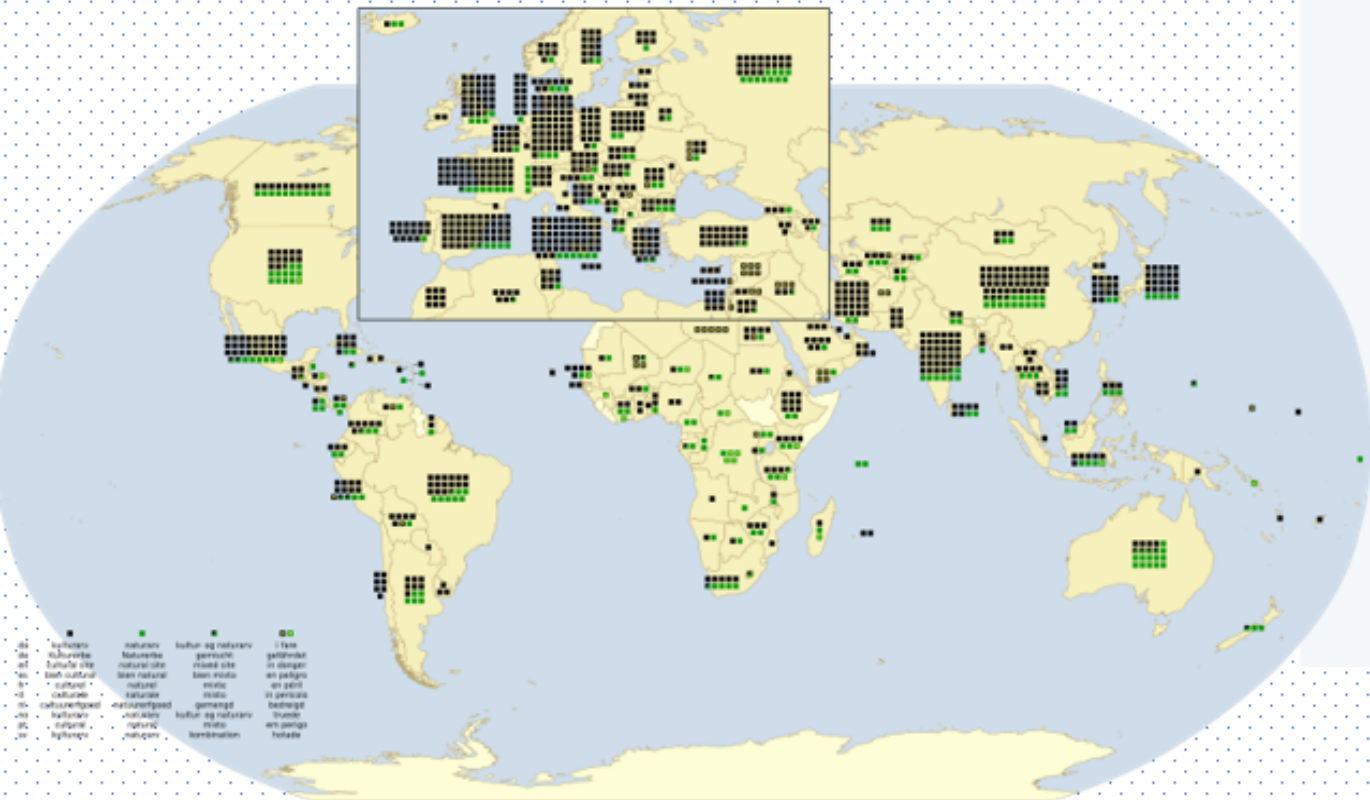
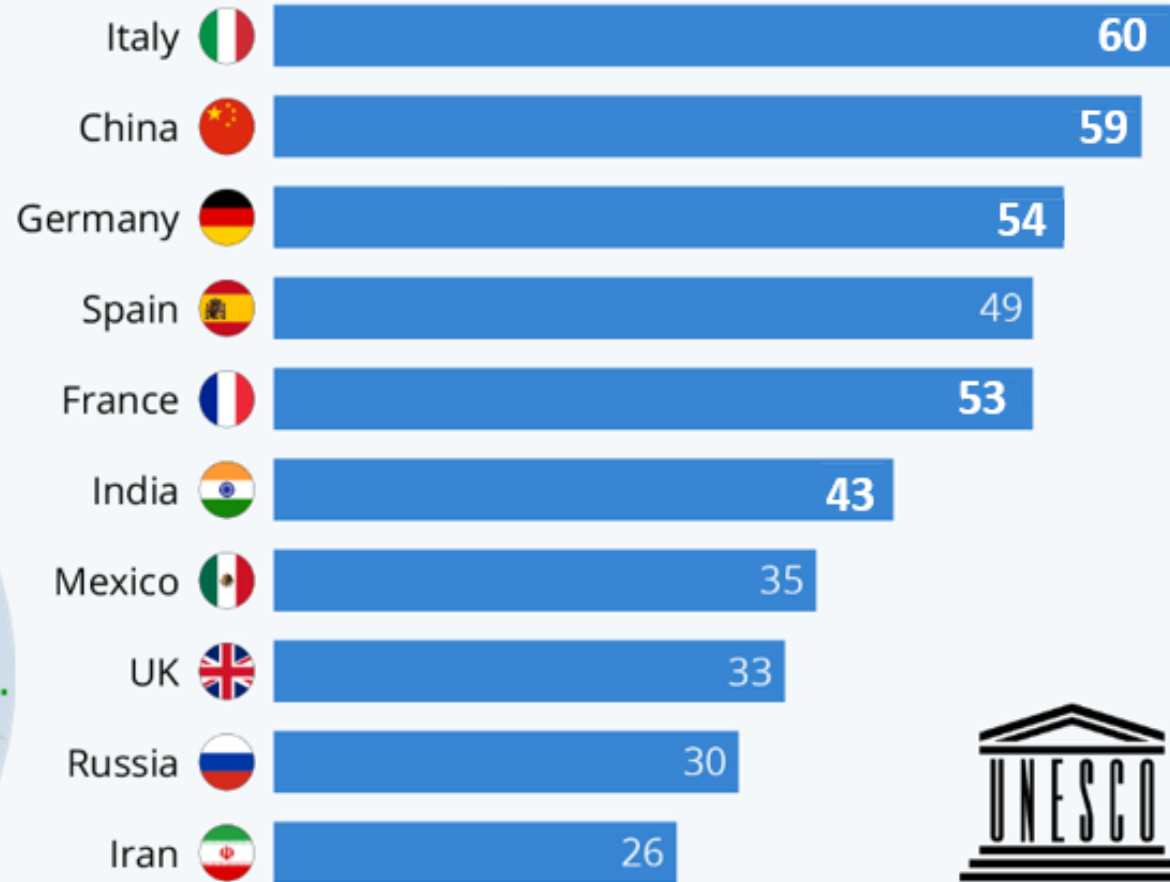

- 3. Testimony to cultural tradition.**

- 6. Heritage connected with events of global importance.**
- 7. Natural phenomena or beauty.**
- 8. Major stages of Earth's history.**
- 9. Significant ecological and biological processes.**
- 10. The vital habitat area.**

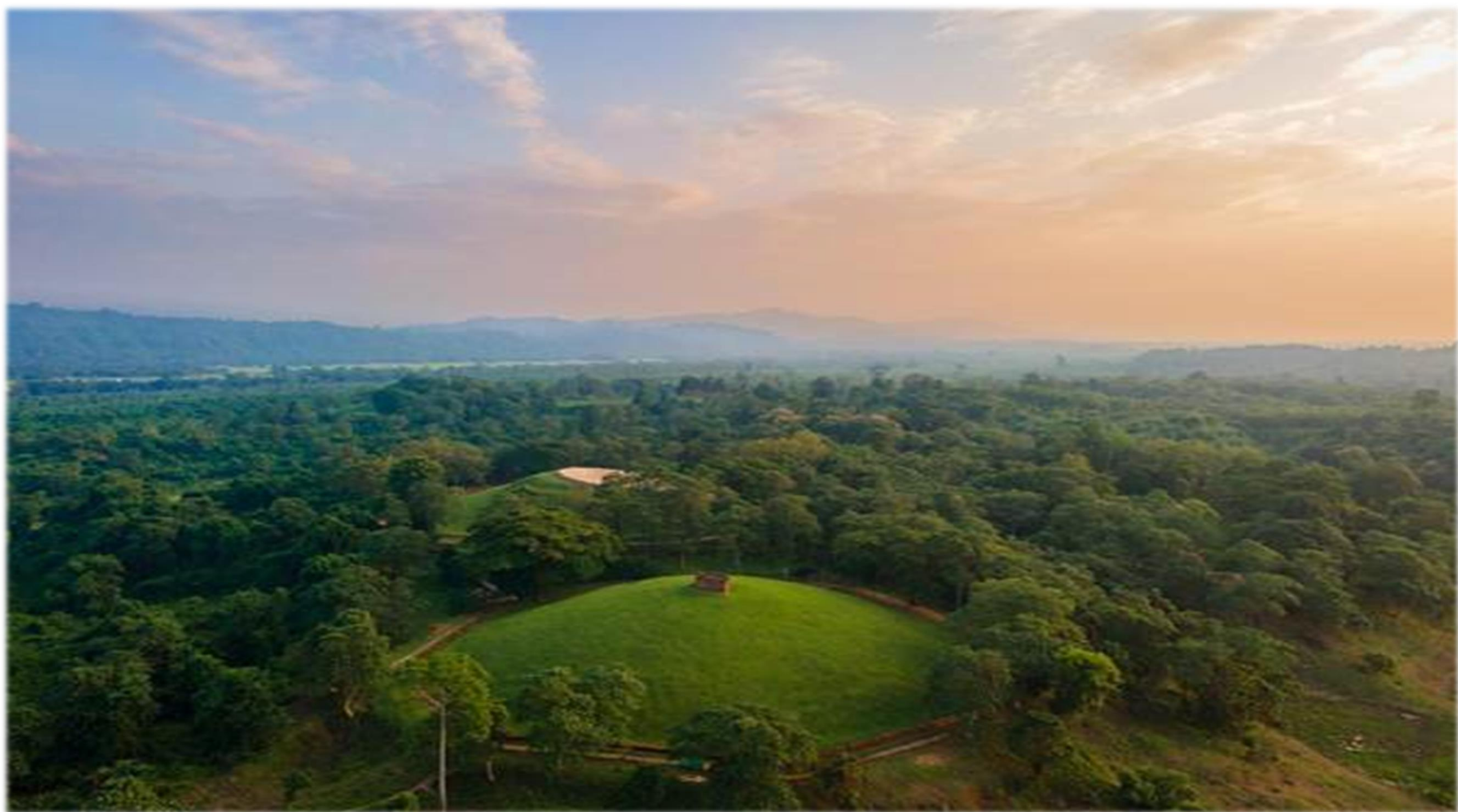

Moidams

- **The Moidams are the burial grounds of Tai Ahom kings and queens.**
- **The Moidams enshrine the mortal remains of Ahom royalty along with the objects they cherished.**
- **The word 'Moidam' is derived from the Tai word Phrang-Mai-Dam or Mai-Tam.**
- **Phrang-Mai means to put into the grave or to bury and Dam means the spirit of the Dead.**
- **They are the resting place of royal families in Assam's Charaideo district.**

Structure: Moidams are hemispherical burial mounds varying in size based on the status of the deceased, featuring a chamber, an earthen mound with a brick structure for offerings, and an octagonal boundary wall with an arched gateway to the west.

Smaller Moidams lack some of these features.

Comparable to: The Moidams are comparable to the pyramids of Egypt.

Practice adopted from: After the 18th century, the Ahom rulers adopted the Hindu method of cremation and began entombing the cremated bones and ashes in a Moidam at Charaideo.

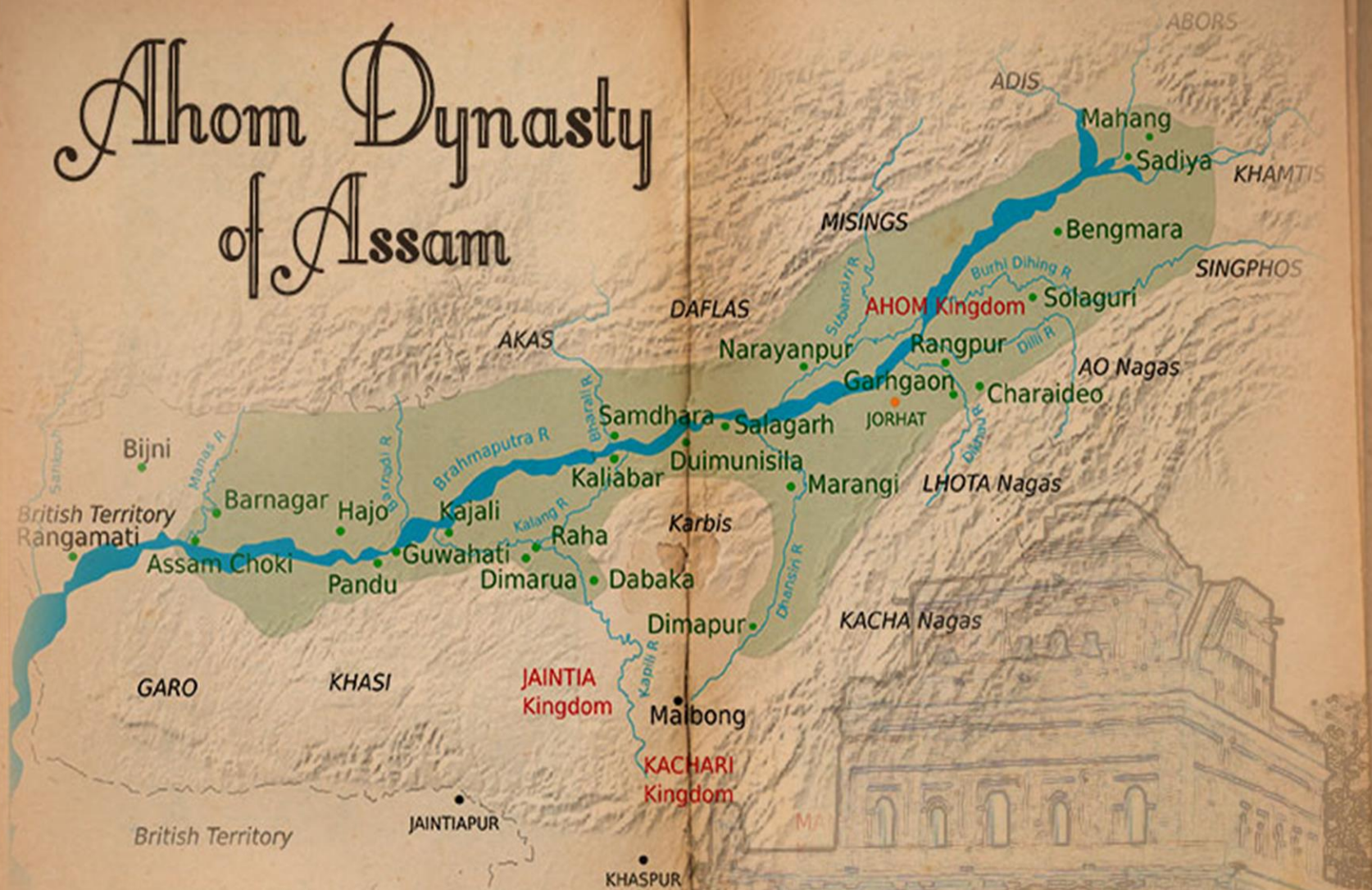

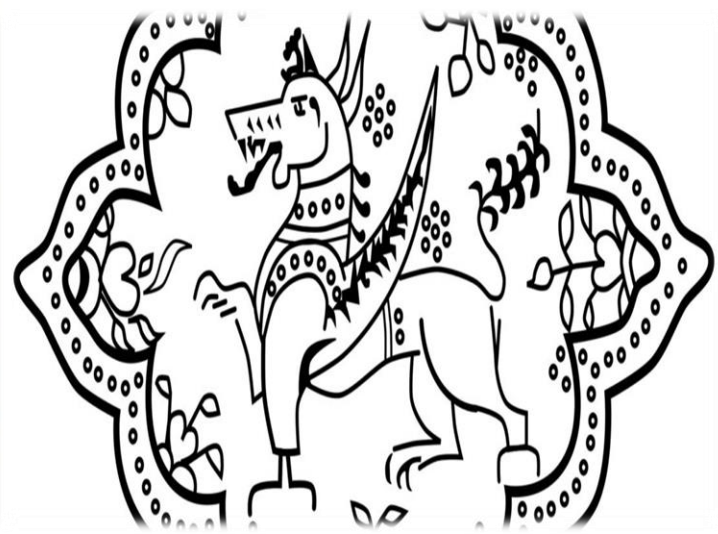
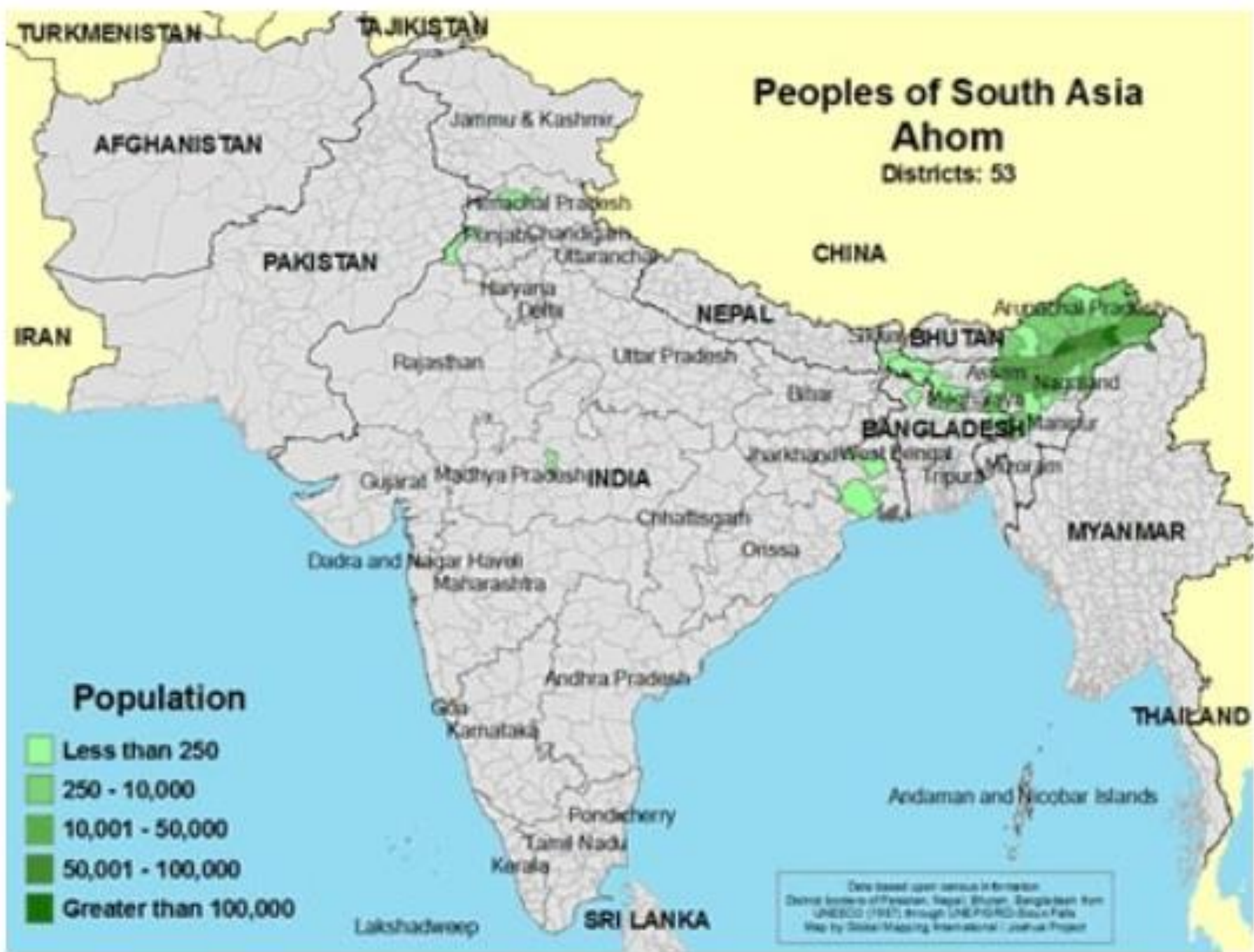
Practice ceased: The burial practice ceased after the Tai Ahom rulers converted to other religions (Hinduism and Buddhism).

Factors Affecting the Property: The main factors affecting the Moidams are heavy rainfall, soil erosion and vegetation growth. These natural elements pose challenges to the preservation and maintenance of the site.

Cultural Significance of Moidams: Ahom Moidams is an exceptional example of a Tai-Ahom necropolis that represents in a tangible way their funerary traditions and associated cosmologies.

Ahom Dynasty of Assam





Ahom Kingdom:

Origins of the Ahom People: Tai-speaking people originated possibly from South China or Myanmar.

- **They migrated to Assam in 1228.**
- **Introduced wet-rice cultivation and state formation techniques.**

Establishment: The Ahom Dynasty was founded in 1228 in the Brahmaputra Valley of Assam by Chaolung Sukapha.

- **Sukaphaa earned the title “Chaolung” for his exceptional leadership.**
- **The Ahom state depended upon forced labour. Those forced to work for the state were called paiks.**

Ahom Religion and Society: Initially worshipped tribal gods, later influenced by Brahmanas and Hinduism.

Mughal Incursions & British Rule: Mughal attempts to capture Assam failed due to Ahom resistance.

- Ahom faced rebellion in the 1800s, eventually succumbing to Burmese invasion.
- The British drove out Burmese in the First Anglo-Burmese War (1824-1826).
- The Dynasty retained sovereignty for 600 years until Assam was annexed by the East India Company in 1826 under the Treaty of Yandaboo.

Administration of Ahoms:

The Ahom kingdom was a well-organized and efficient state. The Dangarias, governors, vassals, and paik officials all played an important role in the administration of the kingdom.

Dangarias: The Dangarias were the *three highest officials* in the Ahom kingdom.

1. **Buragohain** was the prime minister and commander-in-chief of the army.
2. **Borgohain** was the minister of finance and justice.
3. **Phukan** was the minister of foreign affairs and trade.

Governors:

The Ahom kingdom was divided into many provinces, each of which was governed by a governor. The governors were appointed by the king and were responsible for:

- Collecting taxes,
- Maintaining law and order, and
- Defending their provinces from attack.

Vassals

The Ahom kingdom also had many vassals, who were rulers of smaller kingdoms that were allied to the Ahoms. The vassals paid tribute to the Ahoms. They also provided military help when needed.

Paik officials:

- **The Paik system was the backbone of the Ahom military.**
- **Every able-bodied male in the kingdom was a paik.**
- **They were required to serve in the army for a certain number of days each year.**
- **The paiks were organized into units called gots, and each got was commanded by a paik official.**

India has the sixth-most sites worldwide. The first sites to be listed were the **Ajanta Caves, Ellora Caves, Agra Fort, and Taj Mahal**, all of which were inscribed in the 1983 session of the World Heritage Committee. उत्तर प्रदेश पुलिस भर्ती एवं प्रोन्नति बोर्ड द्वारा आरक्षी नागरिक पुलिस के 60244 पदों पर सीधी भर्ती-2023 की लिखित परीक्षा दिनांक 23.08.2024, 24.08.2024, 25.08.2024, 30.08.2024 एवं 31.08.2024 को आयोजित कराने का निर्णय लिया गया है।

2- अवगत कराना है कि यह परीक्षा पूर्व में निरस्त कर दी गयी थी। मा0 मुख्यमंत्री, उत्तर प्रदेश द्वारा निर्देशित किया गया था कि यह परीक्षा 06 माह के अन्दर शुचिता एवं पारदर्शिता के उच्चतम मानकों को दृष्टिगत रखते हुये पुनः आयोजित करायी जाए। उत्तर प्रदेश सरकार द्वारा इस परीक्षा को एक निश्चित समय सीमा के अन्तर्गत शुचितापूर्ण एवं पारदर्शी तरीके से उच्चतम मानकों के अनुसार आयोजित करने की प्रतिबद्धता के क्रम में यह कार्यक्रम घोषित किया गया है।

3- चयन प्रक्रिया को पारदर्शी एवं शुचितापूर्ण ढंग से कराये जाने के सम्बन्ध में परीक्षा सम्बन्धित विभिन्न व्यवस्थाओं यथा-परीक्षा की तैयारियों, परीक्षा केन्द्रों के चयन, परीक्षार्थियों का सत्यापन, छद्मनिरूपण रोके जाने आदि हेतु विस्तृत दिशा निर्देश उत्तर प्रदेश शासन द्वारा दिनांक-19.06.2024 को जारी किए गये हैं। यह परीक्षा इन सभी मानकों के अनुसार की जा रही है।

- ऐसे प्रकरणों में एक करोड़ तक का जुर्माना और आजीवन कारावास तक की सजा,दोनों ही हो सकती है।

5- उत्तर प्रदेश पुलिस भर्ती एवं प्रोन्नति बोर्ड द्वारा "आरक्षी नागरिक पुलिस के 60244 पदों पर सीधी भर्ती-2023" की लिखित परीक्षा उपरोक्त उल्लिखित तिथियों में आयोजित की जायेगी। जन्माष्टमी त्योहार के कारण परीक्षा में अंतराल दिया गया है। उक्त तिथियों को प्रतिदिन 02 पालियों में यह परीक्षा सम्पन्न होगी तथा प्रति पाली में लगभग 5 लाख अभ्यर्थी इस परीक्षा में सम्मिलित होंगे।

6- उक्त परीक्षा में सम्मिलित होने वाले अभ्यर्थियों को उत्तर प्रदेश राज्य सड़क परिवहन निगम की निःशुल्क बस सेवा की सुविधा रहेगी। अभ्यर्थी अपनी सुविधानुसार इसका लाभ ले सकते हैं, जिसके लिए बस से यात्रा करने वाले अभ्यर्थियों को अपने प्रवेश पत्र की अतिरिक्त दो प्रतियाँ डाउनलोड करनी होगी तथा उसकी एक प्रति परीक्षा केन्द्र के जनपद तक की यात्रा एवं दूसरी प्रति परीक्षा उपरान्त अपने जनपद तक की यात्रा के लिए बस कंडक्टर को प्रस्तुत करना होगा।
